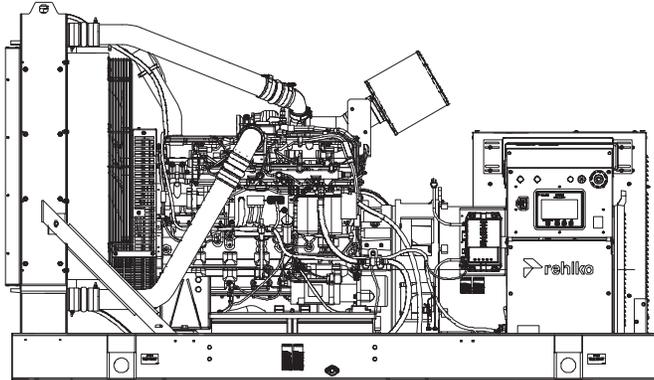

 - The low coolant level and high coolant temperature sensors protect the generator set from overheating.
 - Integral vibration isolation eliminates the need for under-unit vibration spring isolators.
- Mount up to two circuit breakers to allow circuit protection of selected priority loads.


